Call to order, welcome, purpose of working meting; review & approval of October 4, 2019 draft minutes GACA Vice Chair, Belinda Akes called the meeting to order at 9:01 a.m. after, Executive Assistant, Lizette Cordero, conducted a roll call and established a quorum. The Vice Chair welcomed and thanked all Council members for their attendance. The Vice Chair also expressed a special "Thank You" to Becky Brimhall whose term technically ended in December 2018 but continues to serve by attending Council meetings as needed until notice from Boards and Commissions on her replacement and/or the results of the GACA Sunset Review. Vice Chair Akes provided an overview on the purpose of the meeting, and reminded all this is a working meeting and there is not a "Call to the Public" section on the agenda. The public/visitors will not have an opportunity to have any type of dialogue with any Council

member during the meeting. Following, a request by the Vice Chair for review and approval of the October 4, 2019 draft meeting minutes, *David Spelich made a motion to approve the draft minutes as presented; the motion was seconded by Carol Brown. #### Wrap up of 2019

- **Review of tracking grid** Vice Chair Akes discussed the 2019 objectives for all committees, unless noted below, have been completed.
  - AICC Objective #5 Sponsor 1 to 5 Virtual Dementia Tours (VDT) at \$2,000 each (carryover year 3 objective). This objective is on hold until after Sunset Review, Spring 2020.
  - GACA Objective #2 GACA submits an annual end of year written report of its recommendations regarding the State Plan on Aging to the Governor, the Senate President and the Speaker of the House. This objective will be completed in January 2020.
  - LPEC The Legislative Update Report is on hold until the new Executive Director is appointed.
- Requests to the Council Executive Assistant, Lizette Cordero, stated the only request to Council for 2020, thus far, is a sponsorship request for the Caregiver Coalition's Family Caregiver Day in March 2020. As instructed by Council Chair O'Neill, Ms. Cordero forward the GACA Sponsorship request form to Jutta Ulrich from the Caregiver Coalition to review, complete and submit to the GACA by the end of December 2019 for review at the January 2020 GACA Meeting.
- Complete and submit GACA member commitment forms Vice Chair Akes requested All Council Members complete and submit the 2020 Committee Selection & Leadership interest Form included in their meeting packets prior to meeting adjournment. Vice Chair Akes asked Council members to please consider taking on different leadership roles in the upcoming year.

## Establish 2020 objectives and tasks for All Committees and vote

Following a review and discussion of the 2019 objectives the Council agreed and voted on the new objectives listed below for 2020 and will work on task details at a later date. Ms. Brimhall reminded Council there will be a vote on the actions taken at this meeting, however, the Chair may call for an emergency meeting in December to discuss the Sunset Review results/feedback and discuss and/or revote on the objectives below.

• Aging in Community Committee (AICC) – Objective #1 Caregiver Advocacy: Preventing readmissions and after care issues – Task 1. Assemble a panel for discussion. Tasks 2-4 stay the same. Objective #2 Education: Statewide placement for referral services, Tasks #1-4 stay the same, added Task - Assemble a panel for discussion. Objective #3, 4 and 5 and all tasks stay the same.

- Legislative Policy and Education Committee (LPEC) Objective #1 Stays the same, 1 new task New Chair will meet with Legislators to determine date.
- Marketing Committee (MC) Objective 1-2 stay the same. New Tasks #1-3 include ordering business cards, order 2,000 Rack Cards and outreach to promote Council Meeting attendance.
- Executive Committee (EC) Objectives #1 and 3 along with tasks stays the same. New
  Objective #2 Outcome of Sunset Review. New Task #4 under Objective #3 Open
  Meeting Law Training, New Objective #4 Ad Hoc Committee, pending Sunset Review
  feedback, New Objective #5 By Laws Review.
- Governor's Advisory Council on Aging (GACA) Objectives #1-5 along with tasks stay the same, Objective #6 title change to GACA advocates for care recipient/caregiver support and education, advocates for long-term services and supports, home and community-based services as cost-effective way to keep older Arizonans aging in place, Tasks 1-3 stay the same, New Task #4 Advocate for National Caregiver Day, Objective #7 removed.

- Prior to voting for the alternate telephonic meeting dates, a conversation ensued regarding the necessity of the telephonic meetings and possible time change. Former Council Chair, Becky Brimhall and Council member, Carol Brown, suggested the following recommendations:
  - o Continue the telephonic meetings due to the uncertainty of the GACA and pending the Sunset Review decision.

  - Conduct a By Laws review in 2020these meetings are utilized for voting/action to be taken and preparedness for the in person meetings. Vice Chair Akes agreed and mentioned she reviewed the By Laws and noted GACA is required to meet four times per year. Currently the GACA holds six in person meetings annually and telephonic meetings on alternate six months. The Vice Chair stated the current GACA meeting schedule shows a strong commitment by GACA members to meet and get things done. Vice Chair Akes reminded all the call dates/times were selected and previously polled by Council members.
